PRIVACY POLICY OF PANEK UAB

GENERAL INFORMATION

This Privacy Policy of UAB "Panek" (hereinafter referred to as the "Policy") contains information about the methods and principles of processing personal data in connection with the services provided by "Panek" UAB.

Panek UAB pays particular attention to respecting the privacy of all individuals, and therefore the personal data of users of our services and the personal data of other persons are used only for the purposes for which they were collected and for a period of time no longer than is necessary to achieve those purposes. Please read this Policy carefully.

Your personal data is necessary for us to be able to rent you a car or to provide other services to you, and if you do not submit it, we will not be able to provide you with services. This Policy also applies to your personal information that we collect when you use our website.

In processing your data, we comply with the European Union's General Data Protection Regulation (EU) 2016/679 (hereinafter referred to as "GDPR") and other legislation.

Data Controller

The controller of your personal data is UAB "Panek", legal entity code 304445214, registered at Laisvės ave. 125, Vilnius, e-mail address office@panek.lt.

Who do we get your data from?

We receive your personal data directly from you, either verbally when you come to conclude a car rental contract, in writing (by e-mail) or when you make a car reservation on our website.

If you have booked your car through a travel agency, broker, intermediary or reservation system, we obtain the data necessary for the conclusion of the contract (name, surname, telephone number, address, email address, payment details, card details, age, driving record, etc.) from these third parties.

We receive data about your offences or incidents (where damage is caused) from law enforcement authorities (police, customs, etc.) and other entities (e. g. entities administering parking charges), as well as from GPS devices installed in cars (when you are speeding, when you are travelling outside Lithuania, etc.).

If your employer or another company representing you wants to rent you a car, your personal data will be provided to us by these third parties.

What type of personal data we process

We may process the following data about you in the course of providing our services:

- Name, surname, date of birth, address, passport/ID card number, personal code, driving licence number, driving licence expiry date, length of driving experience, telephone number, email address, credit card number, credit card expiry date;
- contractual data, which may include rental information (car category, pick-up and return time, pick-up and return point, extras/services ordered), rental contract number, reservation number, registration number of the rented car, information on customer loyalty and partner programmes;
- special categories of data. In the event of an accident or damage to a car or similar incidents, we process data relating to the course of events and damage caused. Such data may be

provided by customers, passengers or the injured party. The data processed in these circumstances may include data relating to health conditions, such as information on injuries, blood alcohol content, driving under the influence of drugs and similar data.

- GPS location data. All our rental cars are equipped with a GPS location system, so we keep track of the car's movements and location data;
- video footage. We carry out video surveillance at locations where there are information notices about video recording.

For what purpose and on what legal basis we process your data

When you come to our car rental outlet or reserve a car through our rental agents and our website, we process your personal data in order to be able to provide our services to you (to rent a vehicle, to fulfil the rental contract, to provide additional services of your choice, to resolve a dispute).

If during the rental period you are involved in an accident, suffer damage, or the vehicle is damaged or stolen, or suffers a mechanical breakdown, we will process information about the incident, including your report of the incident, and any reports from the police or other third parties, including details of the persons involved, the nature of the personal injuries, and/or the damage to the vehicle. We will use this information for our legitimate interests (for example, to cover any loss or damage to the vehicle); to comply with our legal obligations (for example, to provide the relevant authorities with the necessary incident reports); and to formulate, enforce and defend any legal claims in relation to such incident.

During your rental period, we will collect information about where and when you rented the vehicle, where and when you returned it, as well as insurance preferences, fuel consumption, mileage, accident facts and other information related to the vehicle and your use of it. This information is necessary to enable us to provide you with the services you have requested, either contractually or for our legitimate business interests (for example, to monitor the use of our vehicles). All of our company vehicles are equipped with location tracking equipment so that your location and route are recorded when you use the vehicle.

We will also collect information about any speeding, parking or other traffic-related fines imposed on you during the rental period, or traffic offences committed by you, when such information is provided to us by any law enforcement authority. We will use such information to resolve the payment of a fine or to resolve an offence under a vehicle rental agreement.

Who will we pass your data to?

Your personal data may be transferred to the following recipients or categories of recipients, depending on the situation and the services you use.

What rights can you exercise?

You have the following rights under the GDPR:

- To receive information about the processing of your personal data.
- To have access to your personal data.
- To withdraw your consent to the processing of your personal data.
- To request rectification of inaccurate or incomplete personal data.
- Request erasure (right to be forgotten) of personal data relating to the data subject if this can be justified on one of the grounds set out in Article 17(1) GDPR.
- To request the restriction of the processing of your personal data in one of the cases provided for in Article 18(1) of the GDPR.
- The right to data portability.
- To object to the processing of personal data concerning you.
- File a complaint with a supervisory authority.
- The right to obtain compensation for improper processing of personal data.

You can exercise your rights by contacting us at office@panek.lt You can also lodge a complaint with the supervisory authority, the State Data Protection Inspectorate (contact details at www.vdai.lrv.lt if you believe that we are processing your personal data in breach of applicable law).

If you intend to exercise your rights, we may ask you for identification data, such as your surname, names, driver's ID and any information that identifies you (e. g. the place and date of your last vehicle rental). We also ask you to provide us with the email address or physical address where you would like a reply to be sent.
